**RULES GOVERNING USE OF THE PAVILION**

1. No alcoholic beverages.
2. No fires of any kind without permission - use of gas grills is permitted at the pavilion, but not without prior approval of the WTRC
3. Activity is restricted to that area for which permission has been granted.
4. The responsible party in charge of the activity shall be present before the activity is due to start and remain with the group until all have left.
5. All litter will be placed in the containers provided.
6. No parking on grassed areas.
7. Park is closed ½ hour after sunset.
8. No solicitations without approval of the Township Committee.
9. Abide by all other park rules and regulations as per Ordinance No. 00-09 (copy available at the Administrative office).
10. No raffles may be held without a license (see Township Clerk)
11. No pets are allowed except on walking paths
12. No loud music
