The Permit Number and the date of expiration shall be clearly and conspicuously displayed on the exterior of the donation clothing bin(s), as well as name and address of the registered person that owns the bin(s) and of any other entity which may share or profit from clothing or donation via the bin(s). Also, telephone number of the person's bona fide office, if applicable, the telephone number of the bona fide office any other entity which may share or profit from any clothing or other donations collected via the bin(s).
