

ORDINANCE NO. 2013-03

ORDINANCE OF THE TOWNSHIP OF WASHINGTON, COUNTY OF WARREN, STATE OF NEW JERSEY, REPEALING CHAPTER 19 TITLED “ECONOMIC DEVELOPMENT COMMISSION”

WHEREAS, pursuant to N.J.S.A. 40(55B-3) *et seq.* the Township of Washington had created a local Economic Development Commission known as “Economic Development Commission of Washington”; and

WHEREAS, the Township Committee believes that economic development is important to the future of the Township of Washington; and

WHEREAS, the Township of Washington is committed to promoting economic development where appropriate within the Township; and

WHEREAS, it is the opinion of the Township Committee that the current Ordinance vests too much authority in the Commission; permitting it to sell or lease the Township’s vacant land and to acquire Title to vacant lands for sale or lease to industries; and

WHEREAS, the Township Committee believes that this purpose can be better served with oversight from the Township Committee; and

WHEREAS, it is the intention of the Township Committee to create an Economic Development Committee; and

NOW THEREFORE, BE IT RESOLVED, that Chapter 19, titled Economic Development Commission is hereby repealed:

Section 1:

Severability. The various parts, sections and clauses of this Ordinance are hereby declared to be severable. If any part, sentence, paragraph, section or clause is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of this Ordinance shall not be affected thereby.

Section 2:


Repealer. Any ordinance or parts thereof in conflict with the provisions of this Ordinance are hereby repealed as to their inconsistencies only.

Section 3:

Effective Date. This Ordinance shall take effect upon final passage and publication as provided by law.


