

**ORDINANCE 2013-06
TOWNSHIP OF WASHINGTON
COUNTY OF WARREN
STATE OF NEW JERSEY**

**AN ORDINANCE AMENDING, REVISING, AND SUPPLEMENTING
CHAPTER 117 OF THE CODE OF THE TOWNSHIP OF WASHINGTON,
ENTITLED "VEHICLES AND TRAFFIC" SPECIFICALLY ARTICLE VII,
ENTITLED "SCHEDULES", SUBSECTION THIRTY-NINE,
ENTITLED "SCHEDULE XVII: SPEED LIMITS"**

WHEREAS, the governing body of the Township of Washington desires to impose additional speed restrictions on certain streets within its borders to protect the health, safety and welfare of its citizens; and

WHEREAS, the laws of the State of New Jersey, specifically N.J.S.A. 39:4-8 et.seq. grants authority to the Township to impose certain speed limits within its borders.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Washington, County of Warren, State of New Jersey, as follows:

Section 1. Article VIIA, Speed Limits Section 117-22.1, Establishment of Limits of the Township Code is hereby amended, revised and supplemented by amending the established speed limits for both directions of traffic along Mine Hill Rd. within the Township of Washington.

Section 2. This Ordinance is subject to approval by the NJ Department of Transportation, where applicable.

Section 3. All Ordinances or parts of Ordinance which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistencies only.

Section 4. If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance.

Section 5. This Ordinance shall take effect after final passage and publication in accordance with law.

NOTICE is hereby given that the foregoing Ordinance was introduced and passed on first reading at a meeting of the Township Committee of the Township of Washington, County of Warren held July 16, 2013 and ordered published in accordance with the law.
