

ORDINANCE NO. 2018-02

**ORDINANCE OF THE TOWNSHIP OF WASHINGTON, COUNTY OF WARREN,
STATE OF NEW JERSEY TO AMEND AND SUPPLEMENT CHAPTER 71,
SECTION 71-3, "FEES FOR USE OF THE TOWNSHIP PARK, BALL FIELDS,
TENNIS AND BASKETBALL COURTS AND OTHER FACILITIES," OF THE CODE
OF THE TOWNSHIP OF WASHINGTON**

WHEREAS, the Township Committee of the Township of Washington, County of Warren, State of New Jersey, desires to supplement and amend Chapter 71 of the Code of the Township of Washington in order to update the fees for use of the Ball Fields, Tennis and Basketball Courts.

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Washington, County of Warren, State of New Jersey that Chapter 71 of the Code of the Township of Washington be supplemented and amended to read as follows:

Section 1

§71-3, subsection (A) shall be amended as follows:

§71-3. Fees for use of Township park, ball fields, tennis and basketball courts and other facilities.

A. Ball fields, tennis and basketball courts (team play, per season).
This fee enables a team to use a field for up to 10 hours per week.

(1) Youth Leagues (9-18 yrs.)

<u>Fields</u>	<u>Township Residents</u>	<u>Non-Township Residents</u>
D1-7, F1, P1, S1, S2, S5	\$ 125	\$ 150
S3, S4, PC, BB, VB	\$ 50	\$ 100

(2) Adult Leagues (over 18 yrs.)

<u>Township Residents</u>	<u>Non- Township Residents</u>
\$ 150	\$ 300

(3) Ages 8 and Under No Fee

(4) In order for an organization to qualify for Township resident fee rates, the team must be made up of 50% Washington Township residents. A list of participants with addresses may be required.

Section 2:

REPEAL

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistency.

Section 3:

SEVERABILITY

If any section, subsection, clause or phrase of this ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the remaining portions of this ordinance.

This Ordinance shall take effect immediately upon final publication as provided by law.

NOTICE IS HEREBY GIVEN that the foregoing Ordinance was introduced to pass on the first reading meeting of the Township Committee of the Township of Washington held on February 20, 2018 and ordered published in accordance with the law. Said Ordinance will be considered for final reading and adoption at a regular meeting of the Township Committee to be held on March 20, 2018 at 7:30 p.m. or as soon thereafter as the Township Committee may hear this Ordinance at the Municipal Building, 211 State Route 31 North, Washington, New Jersey at which time all persons interested may appear for or against the passage of said Ordinance.
