

**ORDINANCE NO. 2011-12  
TOWNSHIP OF WASHINGTON  
COUNTY OF WARREN  
STATE OF NEW JERSEY**

**AN ORDINANCE AMENDING, REVISING AND SUPPLEMENTING  
SECTION 117-23 ENTITLED "NO PARKING" OF THE CODE  
OF THE TOWNSHIP OF WASHINGTON "VEHICLES AND TRAFFIC"**

**WHEREAS**, the Township Committee has from time to time considered and reviewed conditions of automobile parking in neighborhoods surrounding public schools located in the Township; and

**WHEREAS**, the Township Committee has placed restrictions on parking in said neighborhoods when, in its determination, it was in the interest of furthering the safety of the students and the residents of the neighborhood to do so; and

**WHEREAS**, the Township Committee, has requested that the Township Police Department observe and investigate the said parking of vehicles along the streets or parts of streets near and/or surrounding Warren Hills Regional High School and make recommendations to the Township Committee; and

**WHEREAS**, The streets listed below have been designated as public roadways of the Township of Washington, Warren County; and

**WHEREAS**, the Township Committee deems it in the best interests of the public, the residents and students of the Township of Washington in the vicinity of Warren Hills Regional High School to restrict parking at any time on streets or parts of streets listed below;

**NOW, THEREFORE BE IT ORDAINED**, Chapter 117-23 of the Township Ordinances of the Township of Washington, Warren County is hereby amended, revised and supplemented as follows to include:

**ARTICLE VIII  
Schedules**

**§ 117-23. Schedule II: No Parking**

In accordance with the provisions of § 117-6, no person shall park a vehicle between the hours specified in Schedule II (§ 117-23) of any day upon any of the streets or parts of streets.

**NOW, THEREFORE, BE IT FURTHER ORDAINED** that regulatory and warning signs, conforming to the current manual on Uniform Traffic Control Devices for Streets and Highways, shall be erected and maintained to effect the above designated parking restriction.

**NOW, THEREFORE, BE IT FURTHER ORDAINED** that, within thirty (30) days of adoption of the within ordinance, the Township Clerk shall forward a copy of the Ordinance to the New Jersey State Department of Transportation.

**NOTICE** is hereby given that the foregoing Ordinance was introduced and passed on first reading at a meeting of the Township Committee of the Township of Washington, County of Warren held August 16, 2011 and ordered published in accordance with the law.
