

**ORDINANCE NO. 2014-06
TOWNSHIP OF WASHINGTON
COUNTY OF WARREN
STATE OF NEW JERSEY**

**AN ORDINANCE AMENDING, REVISING AND SUPPLEMENTING
SECTION 117-23 ENTITLED "NO PARKING" OF THE CODE
OF THE TOWNSHIP OF WASHINGTON "VEHICLES AND TRAFFIC"**

WHEREAS, the Township Committee has from time to time considered and reviewed conditions of automobile parking along the streets or parts of streets located in the Township; and

WHEREAS, the Township Committee has placed restrictions on parking of said streets or parts of streets when, in its determination, it was in the interest of furthering the safety of the traveling public and the residents along said streets; and

WHEREAS, the Township Committee, has requested that the Township Police Department observe and investigate the said parking of vehicles along the streets or parts of streets and make recommendations to the Township Committee; and

WHEREAS, the streets listed below have been designated as public roadways of the Township of Washington, Warren County; and

WHEREAS, the Township Committee deems it in the best interests of the public and the residents of the Township of Washington to restrict parking at any time on streets or parts of streets listed below;

NOW, THEREFORE BE IT ORDAINED, Chapter 117-23 of the Township Ordinances of the Township of Washington, Warren County is hereby amended, revised and supplemented as follows to include:

**ARTICLE VIII
Schedules**

§ 117-23. Schedule II: No Parking

In accordance with the provisions of § 117-6, no person shall park a vehicle at any time upon any of the streets or parts thereof specified in Schedule II (§ 117-23) as follows.

NOW, THEREFORE, BE IT FURTHER ORDAINED that regulatory and warning signs, conforming to the current manual on Uniform Traffic Control Devices for Streets and Highways, shall be erected and maintained to effect the above designated parking restriction.

NOW, THEREFORE, BE IT FURTHER ORDAINED that, within thirty (30) days of adoption of the within ordinance, the Township Clerk shall forward a copy of the Ordinance to the New Jersey State Department of Transportation.

NOTICE is hereby given that the foregoing Ordinance was introduced and passed on first reading at a meeting of the Township Committee of the Township of Washington, County of Warren held May 20, 2014 and ordered published in accordance with the law. Said Ordinance will be considered for final reading and adoption at a meeting of the Township Committee to be held on June 17, 2014 or as soon thereafter as the matter may be heard, at the Washington Township Municipal Building, 211 Route 31 North, Washington, NJ, 07882, at which time all persons interested will be given an opportunity to be heard concerning such Ordinance.
